Edmonds-Woodway parking permits will only be sold to those individuals who meet the following qualifications:

1. **Have no fines/fees.**
2. **Possess a valid driver's license***
3. **Current auto insurance***
4. **Permit fee of \$60 – if writing a check, please make payable to ESD.**

* Items #2 and 3 must be provided along with this application. We can make copies for you.
If all available permits have been sold, a waiting list will be established.

Parking lot rules will be strictly enforced. Rules include but are not limited to the following:

1. **Students may park only in their assigned spot in the large parking lot south of the school and may not park in any other spot.** Violators will first be given a warning and then fined \$20.00; repeated violations may result in loss of parking permit
2. Parking permits must be **clearly displayed** in the front of the car, on or next to the rearview mirror.
3. Students may not use their vehicles during the school day. **NO VEHICLES ARE TO BE USED OR OCCUPIED DURING SCHOOL HOURS.**
4. If students have pre-approval to drive off campus during the school day, (i.e. Running Start students or students with an open period), they may **not** have any passengers.
5. Observe speed limit (5 mph) and regulations as you enter EWHS campus.
6. Parking permits are NON-TRANSFERABLE. They are only for the person/vehicle on this application. (If you change vehicles, please inform the Attendance Office immediately.)
7. A replacement fee of \$20.00 will be charged for lost or stolen parking permits.

Students are advised that the parking lot is not continuously supervised and that students park at their own risk. Edmonds-Woodway High School is not liable for any theft or damage sustained.

I AGREE THAT WHEN PARKING ON SCHOOL PREMISES, I WILL NOT BRING WEAPONS, ALCOHOL, CONTROLLED SUBSTANCES (i.e., ANY UNLAWFUL SUBSTANCE OR DRUG NOT PRESCRIBED TO ME BY A LICENSED HEALTH CARE PROVIDER), TOBACCO, OR OTHER CONTRABAND ITEMS WHICH ARE PROHIBITED BY THE LAW OR SCHOOL RULES. _____ (Initials)

I UNDERSTAND THAT MY VEHICLE PARKED ON SCHOOL GROUNDS MAY BE SEARCHED BY SCHOOL OFFICIALS OR BY LAW ENFORCEMENT AT A SCHOOL OFFICIAL'S DIRECTION IF SCHOOL OFFICIALS DEVELOP AN INDIVIDUALIZED SUSPICION THAT I OR SOMEONE WHO HAS BEEN RECENTLY TRANSPORTED TO SCHOOL IN MY VEHICLE OR THAT HAS BEEN RECENTLY PRESENT IN MY VEHICLE WHILE THE VEHICLE IS ON SCHOOL PREMISES HAS VIOLATED THE LAW OR SCHOOL RULES. THE SEARCH OF MY VEHICLE WILL HAVE A NEXUS, OR CONNECTION, TO THE LAW OR SCHOOL RULE THAT IS SUSPECTED OF HAVING BEEN VIOLATED. I ALSO UNDERSTAND THAT SCHOOL OFFICIALS WILL PERIODICALLY IMPLEMENT TRAINED DRUG DOGS WITH THE ASSISTANCE OF LAW ENFORCEMENT TO SNIFF VEHICLES PARKED ON SCHOOL PREMISES. I CONSENT TO THIS LIMITED INTRUSION BY SCHOOL OFFICIALS AND/OR LAW ENFORCEMENT WHILE MY VEHICLE IS PARKED ON SCHOOL PREMISES. _____ (Initials)

IF A TRAINED DRUG DOG "HITS" OR "ALERTS" ON MY VEHICLE WHILE IT IS PARKED ON SCHOOL PREMISES, I UNDERSTAND THAT THE POLICE MAY REQUEST A WARRANT TO FURTHER SEARCH MY VEHICLE. _____ (Initials).

I ALSO UNDERSTAND THAT THE SCHOOL OR SCHOOL DISTRICT WILL CONSIDER THE REACTION OF THE TRAINED DOG AND MY WILLFUL STEPS TO IMPEDE, OBSTRUCT, OR OTHERWISE PREVENT THE SEARCH OF MY VEHICLE AS PRESUMPTIVE EVIDENCE THAT I HAVE VIOLATED THE LAW OR SCHOOL RULES BY BRINGING CONTRABAND ON CAMPUS. I UNDERSTAND THAT I WILL BE SUBJECT TO STUDENT DISCIPLINE UNDER THESE CIRCUMSTANCES NO LESS THAN IF THE SUSPECTED CONTRABAND WERE RECOVERED FROM MY VEHICLE _____ (Initials).

I HAVE CAREFULLY READ AND INITIALED EACH OF THE PRECEDING PARAGRAPHS AND UNDERSTAND WHAT I HAVE READ. I AGREE TO ALL THE TERMS AND CONDITIONS THAT HAVE BEEN SET FORTH IN THESE PARAGRAPHS.

I ALSO UNDERSTAND THAT FAILURE TO FOLLOW SCHOOL RULES CAN RESULT IN THE REVOCATION OF MY PARKING PRIVILEGES AT EDMONDS-WOODWAY HIGH SCHOOL AT ANY TIME.
